COST OF STUD SERVICE: Cost of stud service \$2,000. The dam owner/lessee is responsible for all collection & shipping costs.

The following is understood and agreed to by the owner/lessor of the forenamed Dam:

1. Negative Brucellosis test, if breeding naturally, within the last 15 days.
2. Owner/lessee of the Dam will be responsible for all shipping and expenses.
3. If Artificial insemination is to be done, all veterinary expenses are to be paid by the owner/lease of the dam. If chilled or frozen semen is to be used, the owner/lessor of the dam understands that all semen collection and shipping costs will be paid before shipping of semen. All collection fees are to be paid directly to the stud's veterinary office. If you choose AI 2xs, you will be charged the collection fee by the vet, but you must provide proof from your vet that the semen was used and not saved. Under no circumstances should the semen be held for any other breeding other than the above Dam within 48 hours of shipping. **Two (2) AI's are recommended in combination with progesterone testing to maximize litter chances and size.**
4. Owner/leaser of Dam agrees to keep Dam confined and away from all other males to prevent her from being bred by any other dog.
5. The guarantee is a litter of two puppies. The stud dog owner will be notified within 40 days of breeding of ultrasound results. If the dam does not deliver two live puppies, the Dam owner will get a second stud service at no charge for the same Bitch. All vet & shipping expenses to be paid by the dam owner for the second breeding.
6. We will allow the Dam owner to keep one (1) breeding female. Under no circumstances should a male be kept for breeding from this litter, unless approved by Southern Coast Goldendoodles. If a male is kept, it would be considered a breach of this contract. Breach of this will result in legal action being taken against the Dam's owner/lessee in the Courts in Gwinnett County, in the State of Georgia, for a maximum sum of \$25,000.00 in liquidated damages. Proceedings will be held in Gwinnett County, GA. **Males can be kept back for breeding from the breeding female you choose to keep back.**
7. All other puppies resulting from this litter, outside of the one (1) breeding female, are to be sold as pets and with strict guidelines of spay and neuter contracts.
8. Non-Disparagement: Dam owners understand that 50% of a puppy's genetics come from the sire and 50% come from the dam. Therefore, both the dam owner and stud owner agree that neither one shall directly or indirectly make or ratify any statement, public or private, oral, or written, to any person that disparages the Sire or Dam. This contract is entered into with good faith by both sire and dam owners.
9. There will be no contracts or restrictions attached to the pick puppy of Southern Coast Goldendoodles. SCG retains the right to keep the pick of the litter as part of their breeding program or sell the pick of the litter.

10. Southern Coast Goldendoodles assumes no responsibility for any accident, injury, illness, or death associated with natural breeding.

11. Any additional or special agreements: Any conditions or provisions must be noted in the space below and signed by both parties to be valid.

This contract supersedes any other written or oral agreements, and by signing this document both parties understand fully the contractual terms specified and agree to abide by all the terms.

The parties agree that this writing represents the entire Agreement between them and that no other representations, either oral or written, have been made regarding the dog described above. The parties further agree that no changes in this contract shall be binding upon either of them without written modifications signed by both parties in the jurisdiction of Gwinnett County, State of Georgia. In the event of litigation arising out of one party. Buyer agrees that he/she understands this contract fully, and that this contract is under the or more of terms of this contract, the non-prevailing party must reimburse the prevailing party for all reasonable attorneys' fees and costs resulting there from. If any provision of this contract is determined by a court of competent jurisdiction to be invalid or unenforceable, that construction shall not affect the remainder of this agreement, which is to be given full force and effect without regard to the invalid or unenforceable provision.

The stud and dam owners agree that this Agreement will be governed by the laws of the State of Georgia and may not be altered, modified, or rescinded unless agreed to in writing by the owner of the stud and dam. This is a legal and binding contract. Breach of this contract will result in legal action being taken in the Courts in the County of Gwinnett County, in the state of Georgia, for a maximum sum of \$25,000.00
